In order to receive the scholarship, I/we understand and agree to the following:

1. I/We must bring our child to school on time and pick up our child on time.
2. I/We will make sure our child attends school every day (except when ill or otherwise excused).
3. I/We will pay any monthly tuition on time that has not been covered by a scholarship grant.
4. A scholarship could pay up to the entire tuition amount, but I understand I/We are required to cover all application and school fees.
5. I/We will submit all registration forms, pay any and all school fees along with this application.
6. I/We will be willing to complete service hours for my child's class, if needed.
7. Scholarship applications will be reviewed and notifications mailed by May 1st.
8. Scholarship offer must be accepted in writing and contract signed by June 1st.
9. Full student fee must be paid by June 1st.
10. I/We allow Logan Christian Academy access to my child's past and future school records.
11. I/We agree to release Logan Christian Academy from any liability in its effort to provide this scholarship.
12. If asked, I/we will provide a personal reference from student's current or past teacher, pastor, or Sunday school teacher.
13. I/We understand that LCA expects parents/guardians to participate and cooperate with LCA policies and guidelines and I/We agree to abide by these policies and guidelines to the best of my/our abilities.



14. I/We understand that all of the above conditions must be met by my child/family in order to be eligible for a scholarship award. I certify that all the information provided on this application is true and complete to the best of my knowledge. I agree to provide proof that the statements are true and I acknowledge that failure to do so will void the scholarship.

The scholarship will be periodically reviewed and can be revoked for cause at any time.
